Canada: Unofficial State sponsor of LTTE Tamil terrorism against Sri Lanka.

LTTE Tamil Terrorist organization was banned in 2006 by Conservative government of former Canadian Prime Minister Stephen Harper. The Tamil Canadian diaspora was formed in Canada as a result of Tamil Terrorist sympathizers who arrived in Canada as refugees. Immigration and Refugee Board of Canada offered automatic refugee status to anyone in Sri Lanka that claimed to be Tamil. As a result, Canada went on to accept the highest percentage of asylum seekers, who were also LTTE Tamil Terrorist sympathizers, then any other country in the world. LTTE supporters found a haven in Canada, an opportunity that they would have NEVER had in Sri Lanka, due to the atrocities LTTE committed. According to this naive policy, the claimants did not even have to prove whether they had ever even been to Sri Lanka!!! For example, MP Gary Anandasangaree of Scarborough Rouge River claimed refugee status in 1983 due to anti-Tamil Black July riots in Sri Lanka that occurred in the same year. However, he was reportedly not in Sri Lanka but in Ireland with this mother.

Tamil Canadians after moving to Canada as refugees, used Canada as a fundraising hub to commit terrorist atrocities against innocent Sri Lankan civilians. LTTE Tamil Terrorists is one of the most ruthless terrorist organizations to have ever existed. They are also the pioneers of suicide bombing, which became their hallmark. This terrorist organization produced the world's most accomplished suicide bombers. These suicide bombing actions resulted in killing Sri Lankan President Ranasinghe Premadasa and Indian Prime Minister Rajiv Gandhi. One of the most notable suicide bombing incidents was when hundreds of innocent ordinary Sri Lankans died in the 1996 Central Bank bombing that killed 90 people.

- Tamil Canadians raised \$7.5 million in Toronto through their fundraising activities to carry out this attack against the innocent Sri Lankans according to RCMP. **Canada took NO ACTION.**
- Many appeals were made to the Canadian Government to investigate LTTE financing and propaganda. There was estimated US \$2 million sent from Canada to LTTE, again **Canada took NO ACTION.**
- Canada's Liberal Party has also contributed to LTTE Tamil terrorism. Liberal Party of Canada has always been eager to support the fast-growing Tamil Canadian community. Former Canadian Prime Minister and Finance Minister, Paul Martin was an avid supporter of the LTTE Tamil Terrorists. Martin dined with a group associated with the LTTE and was even unapologetic about it. Martin went as far as saying that, referring to the LTTE as terrorists was "un-Canadian". As Sri Lankans, this makes us wonder, what does it mean to be a Canadian then? Does that mean being Canadian is equivalent to supporting a barbaric terrorist organization? Again, **Canada took NO ACTION.**

Following the proscription of LTTE as a terrorist organization in April 2006, a few months later in December of the same year, in a Liberal Party leadership convention, there were reported attempts to offer delegate support to leadership candidates such as Bob Rae, in exchange for the promise of removing LTTE, from the list of proscribed organizations. The Liberal government previously feared to ban the LTTE, as it would cause the loss of support from over 250,000 LTTE sympathizing Tamil Canadians.

Here are some more facts presented regarding fundraising for LTTE Tamil Terrorism by the Tamil Canadian diaspora. It is important to note that what is presented here, is just the tip of the iceberg.

- Canada Revenue Agency fined 2 Hindu temples in Richmond Hill and Mississauga. The Richmond Hill Hindu temple donated \$118000 to the LTTE between 2005-2006. Hindu Mission of Mississauga donated over \$85000 through the Tamil Rehabilitation Organization. This organization has been banned in the United States and United Kingdom.
- In 2008, World Tamil Organization was banned for raising funds for the LTTE. According to the RCMP, this is a front organization for the LTTE.
- In 2001, Prapaharan Thambithurai became the first Tamil Canadian charged on financing for terrorism by soliciting donations for the World Tamil Movement. He also plead guilty for fundraising for the LTTE in Vancouver in 2010.
- Canada Border Services Agency asked the Immigration and Refugee Board to issue a terrorism related deportation of a member from the World Tamil Movement that was accused of using pressure tactics to fundraise from Tamil Canadians to be sent to the LTTE. Former leader of the World Tamil Movement, Manickavasagam Suresh was arrested in 1995.
- Tamil Refugee Aid Society of Ottawa was shut down in 2010, after attempting to purchase missiles and AK-47s rifles for the LTTE in 2006.
- Sahilal Sabaratnam, Director of Communications of Canadian Tamil Congress (CTC), Sathajhan Sarachandran, a student at University of Toronto and 8 other individuals were arrested in 2006 by the FBI for attempting to purchase Russian made missiles and firearms worth of \$1 million for the LTTE.
- According to the U.S State Department, World Tamil Movement and Federation of Associations of Canadian Tamils are umbrella organizations for pro-LTTE fundraising groups.



MPP Thanigasalam also introduced Bill 104-Tamil Genocide Education Awareness Week, ridden with factual inaccuracies regarding Sri Lanka and

the last stage of the war, while baselessly accusing the Sri Lankan army of Tamil genocide, when in reality, 295000 Tamil civilians that were held hostage by the LTTE leader were rescued by the Sri Lankan army.
